Soft business conditions...

But we MAY be seeing signs of a coming upturn

Global manufacturing activity continued to soften through late 4Q'11 (*Chart 1*) however the USA outpaced the rest of the world. U.S. unemployment declined and the domestic ISM Purchasing Managers' Index rebounded in November (*Chart 2*).

Electronic equipment shipment growth was at or near zero (3/12=1.0) for most regions in late fall (*Chart 3*). Converted to monthly US\$ shipments, SE Asia ended its "pre-holiday busy season" in November while the other regions remained relatively flat this autumn (*Chart 4*). Examined more carefully Japan and the USA grew modestly while Europe declined.

While electronic equipment demand is static the solar/photovoltaic industry is facing very difficult times. Excess Inventories, aggressive pricing by Chinese PV manufacturers and the end of many government subsidies have combined to hit Taiwan-listed solar/photovoltaic companies very hard. A composite of 17 of these PV firms reported Sept.-Nov. 2011 sales 50% below the same period last year (*Chart 5*).

Capital equipment makers are feeling the effects of the late 2011 electronics slowdown. The SEMI equipment business cycle is much more volatile and lags semiconductors by about six months (*Chart 6*). Similarly PCB capital equipment lags PCB shipments on a 3/12 growth basis (*Chart* 7). When semiconductor chip and PCB growth resumes in 2012 the capital equipment makers will likely see their "recoveries" delayed by about six months.

Looking forward there may be "light at the end of the tunnel." Despite global economic woes the entire electronic equipment supply chain may be approaching the trough of this current business cycle (Chart 8). Resumed growth (3/12 > 1.0) appears likely to begin in early to mid-2012. Our crystal ball is still hazy but we'll be watching the monthly growth rates very carefully.
