# 2013: A single digit growth year?

Global electronic equipment production peaked seasonally in late 2012 with the vast majority of the late year growth in SE Asia (*Chart 1*). Domestically electronic equipment production has been contracting since 2010 but it increased slightly this past fall (*Chart 2*).

Global semiconductor shipments finally crossed the "growth" line into positive territory in November and Custer Consulting Group's world semiconductor leading indicator points to a modest continued expansion in 1Q'13 (*Chart 3*). However based upon the SIA's region statistics (*Chart 4*) chip shipment growth was driven by SE Asia and N America with Japan and Europe lagging badly.

In China/Taiwan the major ODM companies (led by Foxconn) had a record year, peaking seasonally in November and generating a 4% composite annual sales increase in 2012 vs. 2011 (*Chart 5*).


Globally PCBs, semiconductors, electronic equipment and the Global PMI leading indicator all have recovered to indicate real growth (3/12 >1) with further but subdued expansion likely in early 2013 (*Chart* 6). Of course the results will vary regionto-region with Europe and Japan still struggling.

Looking forward *Chart 7* summarizes recent growth forecasts for the global electronics supply chain in 2013. Conditions are still tenuous but this year looks like one of a mid-single digit world expansion driven by SE Asia.

# **End markets**






